Amidst the COVID pandemic, Washington imposed some 50 new restrictions targeting Cuba, on top of the more than 200 added during the Trump administration. This affected medical donations and the purchase, payment and shipping of medicines, medical supplies and equipment. This <u>analysis and virtual event hosted by the National Security Archive and the Washington Office on Latin America</u> breaks down the effects of U.S. sanctions on Cubans' health during the global pandemic.

For almost 60 years, the United States has enforced sanctions against Cuba that "impede its 11 million people from freely engaging with the US and beyond…a barrier to the full exercise of Cubans' rights," according to the 2021 Oxfam report *Right to Live without a Blockade: The Impact of US Sanctions on the Cuban Population and Womens' Lives*.

Denial of Food and Medicine: The Impact of the U.S. Embargo on Health and Nutrition in Cuba

Water quality, food security, medicines and medical equipment: "The embargo has closed so many windows that in some instances Cuban physicians have found it impossible to obtain life-saving medicines from any source, under any circumstances," according to this seminal report published in 1997. The report's Executive Summary highlights the most egregious measures affecting the health and wellbeing of Cubans, ones that persist today.
